Revenue Agreement Amendments: SD Department of Education amend agreement to conduct SD DOE Menu of Options Training and to prepare to deliver SD Menu of Options between April 14, 2014 and May 31, 2016 at a rate of \$600 per day not to exceed \$373,200.
