an instructional coach to design and deliver regional trainings between June ,1 2015 and January 1, 2016 at an amount not to exceed \$5,300; State of South Dakota to prepare and conduct presentation to the School Support Team relative to Principal Effectiveness, between July 15, 2015 and July 24, 2015 at a rate of \$600; McCook Central School District to provide Job Shadow Placement Services between July 1, 2015 and June 30, 2016 at a rate of \$1,421; State of South Dakota to amend previous contract for math and reading coaching to redefine the tasks to be performed between June 1, 2014 and June 26, 2016. No change to the contract amount. Expense Agreement: Kerri Whipple to provide a Title III presentation between June 16, 2015 and June 29, 2015 at a fee not to exceed \$2250 plus expenses not to exceed \$438.46.
